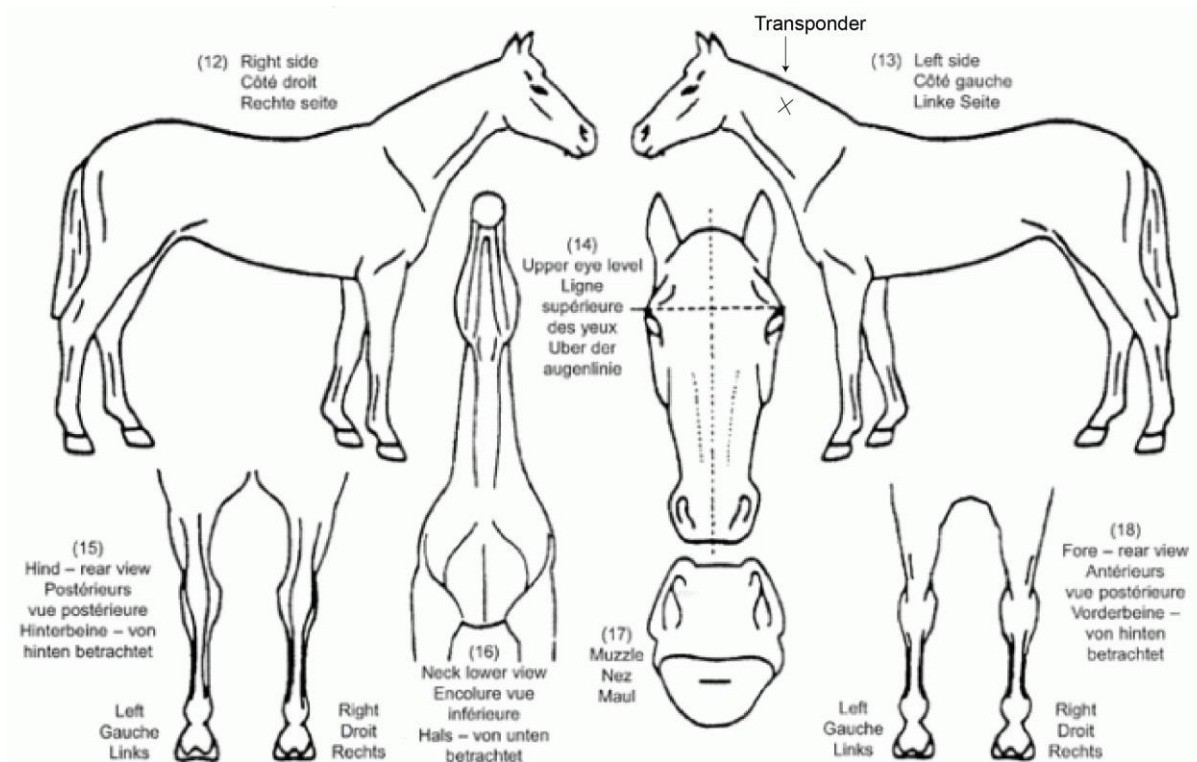

The foal can only be registered after DNA research has been carried out.

Hair samples for DNA testing from the sire, dam and foal are to be placed in separate, resealable bags and clearly labelled on each bag e.g. Sire's name, Dam's name, Foal's name.

This form must be sent to the KFPS no later than 6 days after it has been completed. **The validity of this form will expire after 6 days.**
